### Institution Policy for Disabled (DIVYANGJAN)

GRY Institute of Pharmacy, Borawan encourages all students to participate. In this regard, the institute supports education while also assisting differently abled students in finding jobs.

The following policies have been established by the college to assist all students with disabilities.

- To give personal and professional therapy while keeping their unique requirements in mind.
- Hostel fees are waived to enable students with impairments from rural backgrounds to pursue higher education.
- Will not deny entry to anyone because they are differently abled.
- Disseminate information about government or university orders concerning fee reductions, test procedures, reservations, rules, and other issues affecting differently abled people.
- Assess the ability of differently abled students and assist them in getting appropriate employment by providing special training facility.

**Support System:** A support system allows individuals with disabilities to move around securely and freely while also taking advantage of the built environment's amenities. The purpose of disabled-friendly equipment is to provide an atmosphere that encourages individuals to function independently so that they can engage in daily activities without assistance. Railings are used to support the building to the greatest extent possible for accessibility. The ramp must be wide enough for a wheelchair to pass over without difficulty. The institution also provides a wheelchair.

**Disabled friendly Washrooms:** On the ground floor, there are separate washrooms with Western Waters Closets and grab bars. Toilets must be large enough to allow for free movement of students of various abilities.

**Scribes for Examination:** The institution must supply or permit the use of scribes for students who require them while taking tests. On the recommendation of the Principal, the head of Examinations shall authorize the student to offer extra time to impaired candidates for responding papers at University examinations

- The scribe must not be a family member of the student appearing in the examination.
- The scribe's educational qualifications must be lower than the examinee student's.
- The scribe must provide a proforma with a declaration in the format specified by the institute. The scribe's signed pro forma must be delivered to the institute.
